Entrepreneurial Summer Camp

1. Purpose:

The camp aims to encourage the exchange of innovation ideas and entrepreneurship thinking for the youth from universities and colleges in Asia. Through this program, we hope to facilitate cross-border startups, promote and share the development of regional economic resources and services. The 10-days program will include entrepreneurship courses, business ideas exchanging (between the participants and the investors), company visits, and cultural experience trips. *For the ideas exchanging on the last day of the camp in terms of final pitch day, there will be chances for potential teams to win venture capital from those experienced angel investors.

6. Eligibility:

- For domestic or abroad (New Southbound Countries) colleges or universities students (Bachelor, Master, PhD) who are interested in the innovative entrepreneurship.
- Official numbers of admission are 40 students, which include 25 students from New Southbound Countries (5 international students studying in Taiwan) and 15 domestic students. 50 students from New Southbound Countries and 30 from domestic are on the waiting list for admission additionally. Those who are accepted in the initial trial should reply the willingness for attendance on time or the qualification will be replaced by those on the waiting list.
- Participants' fluency on survival English are strongly required.

10. Course Plan

- Ice-breaking: Through Ice-breaking activities will help team members to get to know each other.
- Team Matching: Participants will be asked to come up with a business idea, and some of the ideas will be selected for further discussions. Later, participants will be divided into groups to discuss on the selected project for further interaction with students from different countries.
- Idea Inspiration: Design thinking courses will help participants to re-exanimate the feasibility, market-driven possibilities, innovative of their business/product idea.
- Innovation Practice: By using the equipment in Fi-Lab, participants will be able to make prototypes based on their ideas.
- Company Visit: Successful entrepreneurs will be invited to give speeches to students for their better understanding of worldwide entrepreneurship incubation environment and resources.
- Ideas Exchanging: Pitch to angel investors, specific teams might be funded if investors are

interested in their ideas.

11. Subsidy and Expense:

- The students accepted in the initial trial can participate in this camp for free. We offer full subsidy for accommodation and meals during the program (personal expense is not included). For domestic student or international student in Taiwan, we offer one round-trip travel allowance from north of Chiayi to Kaohsiung (price will be determined according to the location of your school or domicile) HSR, Train, Bus regular/student tickets are all accepted, and will be reimbursed by actual expenses. For the foreign student accepted in the initial trial (non-Taiwanese nationals and studying abroad), the organizer will offer the round-trip economic class airfare departed from the participant's home country to Taiwan.
- •All admitted participants' flight tickets are required to pay in advance by themselves as the guarantee deposit before the camp starts, and which will be refunded at the last day of the camp.
- •After the camp, the implementer will provide a 6-month usage of school working space and professional consultant for helping the team that was built during the camp to make connection to local resources and to apply for domestic fundraising.
- •For those who participate in whole activity will be given a certificate of participation.
